## RESOLUTION OF THE MONCLOVA TOWNSHIP TRUSTEES 104

## ESTABLISHING THE NECESSITY FOR ON STREET PARKING REGULATIONS

May 20, 2019

Resolution No. 05202019-01

Trustee Craig offered the following resolution:

WHEREAS, township regulation of the use of township streets or highways which does not conflict with standards set by statute or specific powers vested in other authorities is authorized by Ohio Revised Code §505.17; and,

WHEREAS, it has been determined that the public safety and general welfare of all persons using township streets and roads will be improved with the additional regulation of on street parking; and,

WHEREAS, such additional regulation has been determined to be reasonable, is not discriminatory, is of uniform operation, has a real and substantial relation to its purpose and does not interfere with private rights beyond the necessities of the situation;

**NOW, THEREFORE BE IT RESOLVED** by the Board of Trustees of Monclova Township, Lucas County Ohio, that:

**Section 1:** The storage or apparent storage of vehicles, recreational vehicles, commercial vehicles and trailers in the street is prohibited. A vehicle may be considered as being stored if it meets any of the following descriptions:

- It is in the same position for more than seven (7) days;
- It has a flat tire;
- It is considered a junk vehicle;
- It is under a cover or tarp.

Section 2: No parking is permitted over public sidewalks.

**Section 3:** Vehicles shall be parked within 12" of the curb.

**Section 4:** Commercial vehicles, recreational vehicles and trailers shall not be parked in the street, except while loading or unloading, if it can be done safely and only for a reasonable period of time necessary for such purpose. Commercial vehicles may be parked in the street for the duration of their business during normal business hours.

Section 5: No vehicle parked in the street shall be parked in a way that creates a safety hazard or that blocks vision.

**Section 6:** Any vehicle found to be in violation of this resolution may be subject to a citation and penalty if not moved within 24 hours of a written notice. Any vehicle found to be a safety hazard shall be considered an emergency and may be towed at any time at the owner's expense.

**Section 7:** Whoever violates this Resolution is guilty of a minor misdemeanor by virtue of Ohio Revised Code Section 505.99. Penalties shall be imposed in accordance with Ohio Revised Code Section 2929, and shall include a fine up to seventy five dollars (\$75.00) for each offense. Each day of violation constitutes a separate offense.

**Section 8:** This Resolution shall become effective upon the latter of (i) thirty (30) days following posting of this Resolution in five (5) conspicuous places in the township, and (ii) publication of this Resolution in a newspaper of general circulation in Monclova Township for three (3) consecutive weeks.

**Section 9:** This Board finds and determines that all formal actions of this Board concerning and relating to the adoption of this resolution were taken in an open meeting of this Board and that all deliberations of this Board that resulted in those formal actions were in meetings open to the public in compliance with the law.

Trustee Lang seconded the adoption of this resolution. The vote, upon its adoption, resulted:
