## **Review of Minutes:**

Lang moved to approve the minutes from the March 16, 2023 meeting and  $2^{nd}$  by Fallows. All in favor and approved unanimously.

## **Revision of Application for Jobs Creation Grant:**

Attorney Sanderson revisited the application and sent revisions to the board as requested from the March 17<sup>th</sup> meeting. The contract has been reviewed and there have not been any applicants for revisions. The board members agreed to have the conversation tabled. Fallows commented that the real purpose of JEDZ was for the three entities to make money. Pike commented that as a business owner the grant is not a huge incentive for businesses to move to the Monclova area. Burtch agreed with Gavin's comments. Elmore agreed that the collaboration was to make money and if someone is turned down in may have a negative feeling for the township.

Lang, moved to discontinue the use of the MMT JEDZ jobs creation grant for a new application as of Wednesday, April 19, 2023. Future economic development in the zone will be handled through projects designed to improve infrastructure and increase opportunity. Fallows made the motion and Selhorst 2<sup>nd</sup>. All agreed unanimously.

Selhorst asked that a round table meeting with engineers be scheduled to discuss what roads/properties are available and what it is slated for. Fallows commented that the bylaws may need to be reviewed. Review how infrastructure should be funded. Sanderson will research further.

A motion was made to approve Secretary, Kelly Jo Nehay 1st Quarter hours, Fallows 2nd and all agreed unanimously.

Discussion took place about holding meetings on a quarterly basis: January, April, July and October.
