2023 ACCOMPLISHMENTS

Happy Holidays from your Monclova Township Elected Officials and staff! As we look back on 2023 we wanted to share some of the work accomplished by in the township during this very productive year.

- Hired new Fire Chief Matt Homik to lead our fire ~EMS services and staff members through historic activity.
- Employed a new Road Maintenance Superintendent, Doug Holland, who directs five employees, which includes a recent hire. Another onboarding will occur in January.
- Zoning Administrator Wagner issued 66 new home permits, in addition to the other permits, site plan reviews, nuisance complaints and other responsibilities he attends to.
- Congratulations to Road Department team member Todd Wilson for 16 years of service and best wishes in retirement.
- Resurfaced 3.1 road miles in Crosscreek Woods Plats 1-4, Homestead Plats 1-7, and Stonebrooke Lane
- Crack sealed 4 miles of roads in The Quarry, Stonegate, Salisbury Landings
- Purchased Ford F550 to replace 16 year old vehicle.
- From January October 2023 MTFD dispatched to 1,784 incidents for response by fire and EMS department personnel.
- 288 fire prevention and public safety education activities have been conducted by MTFD from January October, 2023.

COMMERCIAL ZONING CHANGES

The northwest corner of Briarfield Boulevard and Maumee-Western Road was recently approved for a zoning downgrade from M-1 Industrial to C-2 Commercial for a proposed small shopping

A January hearing for the opposite northeast corner of this intersection will ask for the same zoning downgrade, with the owner of this property proposing a gas station and convenience




Friendship gas station at Monclova and Jerome Road is progressing, with hopes of a late spring opening.

LOOKING TOWARDS 2024

Each year the township departments work with Fiscal Officer Pike and Administrator Grim to develop goals that are incorporated into the budget for the following year along with the five-year projected plan. Lucas County has a similar project development. Here is a list of projects that you can anticipate this coming year:

- ✓ A 5,000 sq. ft. addition to the Equipment Storage Building at the Maintenance Department on Keener Road as well as potential additional parking.
- The township's road resurfacing project includes Waterside Plats 1 through 17 as well as Olde Town at Waterside Plat 1 (the public road portion) for a total of 4.5 miles.
- The Lucas County Engineer has scheduled construction of a new roundabout at the intersection of Holloway Road and Salisbury Road.
- The Lucas County Engineer has scheduled replacement of the Monclova Road Bridge over Blystone Ditch, located just west of Coder Road. This project will occur the first quarter of 2024.
- Monclova Road Sanitary Sewer Project will commence July, 2024. Construction will originate at 8080 Monclova Road and extend just beyond 7720 Monclova Road. Notices to affected property owners will be sent as this approaches.

OBTAINING AREIS INFORMATION

Inquiries are often made of our Zoning staff for property details when applying for a deck, fence, or other issues. This information is readily available to all from the Office of the Lucas County Auditor – Real Estate Division through AREIS Online: co.lucas.oh.us/377/AREIS-Information

This feature offers significant mapping and imagery with some highlights being:

- Lucas County Map-Search by address or intersection.
- Identify parcels one at a time.
- Select multiple parcels by free-hand, box, polygon or line.
- Select parcels by buffer. Measure distance, area, and latitude/longitude.
- View aerial orthophotography (top down) for different years.
- Download or print maps in different sizes and
- View map layers including floodplain, soils, zip codes, census tracts, building footprints, market areas, school districts, and more.
- Front structure photos-street level imagery is taken every six years via the county-wide revaluation.
- View street-level imagery for different years for virtually every property in Lucas County.
- Zoom in and out on the image.
- Expand photos for large printing.
- Download and print photos this comes in handy for those deck and fence permits!

Additionally, you can also view the current tax bill, see property attributes, assessments, breakdown of taxes. For personal assistance with the program contact the county at 419-213-4406.

DRUG DROP-OFF

Monclova Township, Monclova Fire~Rescue, and the Office of the Lucas County Sheriff have partnered with AWAKE Coalition to provide a drug collection unit at the Administrative Offices (4335 Albon Road). This provides residents with a safe and environmentally responsible way to dispose of unwanted medications – pill only. The unit is continuously to the public during normal office hours, typically Monday,

12-4, Tuesday through Friday,

Again, this service is for pill only disposal.

TRASH SERVICE COVERED UNDER THE CONTRACT WITH REPUBLIC SERVICES:

- Normal household waste for weekly Wednesday collection unless followed by a major holiday, then one day delayed.
- Apartment rentals are not covered under the township's residential services.
- One township-provided trash toter is your limit with our service. Toter limit refers to the specific toter you received from Republic Services.
- Trash must be out by 7:00 AM. Changes in weather, crew assignment, etc. may alter your typical collection time, but placement must always be before 7:00 AM, Large-scale changes are announced on Monclova Alerts (see monclovatwp.org).
- Large item pickup: Asterisk (*) on calendar indicates a possible collection date. You are allowed one large item per month at no cost. At least 48-hour advance notice must be given to Republic staff at 734-848-5226.
- No construction or remodeling debris.
- No item will be accepted that will harm a sanitation worker or a truck, i.e. pool chemicals, gasoline, steel pipe, excessive weight of container.
- NO LOOSE GARBAGE in your toter.
- Recycling service is every-other-week per your route schedule (N or S on calendar). NO PLASTIC BAGS IN RECYCLING TOTER. All items should be loose.

MISSED? The truck will not come back if you did not place your toter out by 7:00 AM LIMIT ON TRASH: One Republic Services toter. No trash above toter line or on the outside of toter. Consider waste reduction through seasonal yard waste disposal at Ohio Compost, 10839 Sager Road, 419-897-7807. This is a fee-free, seasonal drop-off for township residents.

DEFINITIONS:

LARGE ITEM: Examples-chair, mattress, stove, refrigerator (must have technician verification that Freon has been removed)

YARD WASTE: Contained yard waste (in regular trash bag) is accepted in toter. Township Guidelines must be adhered to (watch excessive weight, all items within toter, etc.). Township-provided fee-free seasonal drop-off at Ohio Compost is also an option. CONSTRUCTION DEBRIS is not allowed through the township program. This would involve building material, repair, demo.
