

During this vulnerable time, Monclova Township Fire-EMS and Administration are working diligently with the Toledo-Lucas County Health Department, Lucas County EMA, and the Ohio Department of Health regarding the Coronavirus Disease 2019 (COVID-19). The situation is fluid. We will take necessary precautions to help minimize the amount of people affected and to help slow the threat of the virus.

As a result of this commitment, on March 18 all Township facilities were closed to the public until further notice. The public closure includes the Administration Building, 4335 Albon Road; the Road Maintenance Facility as well as the cemetery office, 4650 Keener Road; and the Fire Department Administrative Offices, 4395 Albon Road. Since that time Governor DeWine has also directed playground structures to be off limits to the public. This includes Keener Park (Keener Road) and Community Park (Albon & Monclova Rds.). Restrooms, walking trails, and open space will remain open to the public.
